

All that certain piece, parcel, or lot of land in the Town of Simpsonville, County of Greenville, State of South Carolina on southerly side of Cloverdale Lane, being shown and designated as Lot No. 163, on plat as Section I, Bellingham, recorded in the RMC Office for Greenville County, S. C., in Plat Book "4N", at Page 22, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the southerly side of Cloverdale Lane joint front corner of Lots Nos. 162 and 163, and running thence with the joint lines of said lots, S. 1-56 W. 188. I feet to an iron pin; thence N. 61-00 W. 50 feet to an iron pin at corner of Lot No. 166; thence with the line of Lot No. 166, N. 80-06 W. 52.5 feet to an iron pin at joint rear corner of Lots Nos. 163 and 164; thence with the joint lines of said lots N. 8-26 E. 150.6 feet to an iron pin on the southerly side of Cloverdale Lane; thence with the southerly side of Cloverdale Lane, N. 85-49 E. 80 feet to the point of beginning.

The within conveyance is subject to restrictions of record, and is also subject to utility easements and rights-of-way of record or on the ground, along with top fees, set back lines, and zoning regulations and is particularly subject to a sewer and drainage easement along the rear line of said lot, as shown on recorded plat.


