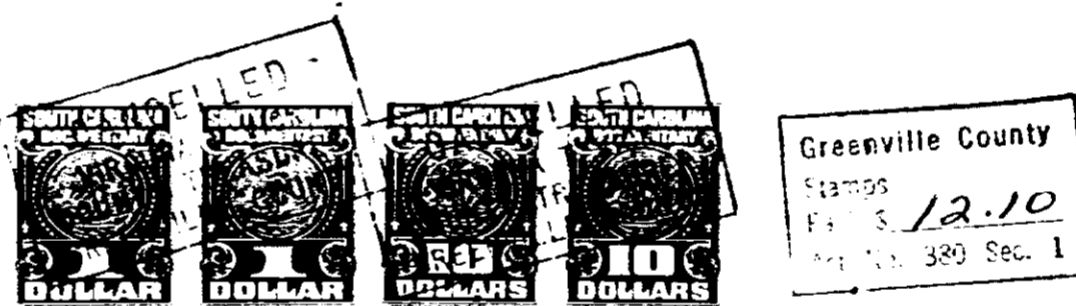
KNOW ALL MEN BY THESE PRESENTS, that **HOLLY TREE PLANTATION, A Limited Partnership**
