ALL that piece, parcel or lot of land situate, lying and being on the Southwestern side of Circle Road, Paris Mountain Township, Greenville County, State of South Carolina, as shown on plat of Property of W. D. Black, Berea Sec., Greenville County, S. C., made by C. C. Jones, Civil Engineer, August 14, 1958, recorded in the R. M. C. Office for Greenville County in Plat Book "FFF", at Page 112, and having the following metes and bounds, to-wit:
