AND WHEREAS, Said Declarants and Petitioners further declared and affirmed:

FIRST: Their names and residences are as above given.

SECOND: The name of the proposed Corporation is THE FULL TRUTH GOSPEL CHURCH OF JESUS CHRIST OF THE APOSTOLIC FAITH, INCORPORATED OF GREENVILLE, S. C.

THIRD: The place at which it proposes to have its headquarters or be located is 38 East 5th Street Greenville, S. C.

FOURTH: The purpose of the said proposed Corporation is exclusively Religious, charitable, Educational, and recreational; to conduct religious services, ceremonies, and schools; (including nursery and day care), and to exercise certain moral and spiritual and charitable functions consistent

with Christian Doctrine of the Apostolic Faith; This Assembly (Church) is a nonprofit organization; Proclaiming the Gospel of Jesus Christ, (Romans 1:16), and the word of God. (Hebrew 4:12; 6:5; 11:3; and II Peter Commence of the State State 3:5;).
