

the receipt of which is hereby acknowledged, have granted, bargamed, sold, and released, and by these presents do grant, bargain, sell and release unto WILLIAM E. WRENN AND MARY ELLEN WRENN. their heirs and assigns forever;

ALL that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina and being known and designated as Lot No. 11 on a Plat of Spring Valley Subdivision, dated August, 1963, and being recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book XX at Page 157 and having the following metes and bounds, to-wit:

BEGINNING at a point on Spring Lake Road at the joint front corner of Lots Nos. 11 and 12 and running thence N. 3-00 W. 127.7 feet to an iron pin; thence running along the property of W. H. Kelley N. 86-57 E. 164 feet to an iron pin; thence running along the common line of Lots Nos. 10 and 11 S. 3-00 E. 127.85 feet to an iron pin on Spring Lake Road; thence running along Spring Lake Road S. 87-00 W. 164 feet to the point of beginning.

This conveyance is subject to Protective Covenants recorded in Deed Book 775 at Page 6 as well as any other restrictions, easements or rights-of-way affecting the property of record or otherwise.

As a part of the consideration herein the Grantees agree not to have any barking dogs on these premises and further agree that should the Grantors be required to install a sewer digester, the Grantees agree to pay One Twenty-Fourth (1/24) of the costs of such installation within a period of Three (3) years after completion of same, PAYABLE one-third (1/3) each year.
