UNITED STATES MARSHAL'S DEED

WHEREAS, the United States of America, for and on behalf of its agency, the Farmers Home Administration, on or did file its complaint 2nd dayof April, 1974 about the in the District Court of the United States for the District of South Carolina against John Black and Sue N. Black, following which the matter came before the Honorable Robert W.
