

STATE OF SOUTH CAROLINA) AMENDMENT AND RELEASE OF RESTRICTIVE
 COUNTY OF GREENVILLE) COVENANTS, EASEMENTS AND RESERVATIONS

WHEREAS, Camelot Subdivision, in Austin Township, Greenville County, South Carolina, as developed by Camelot, Inc., a corporation, is shown on a plat thereof made by Piedmont Engineers and Architects, dated November 5th, 1968, and recorded in the RMC Office for Greenville County, South Carolina, in Plat Book WW, pages 46 and 47.

WHEREAS, Lots Nos. 1 through 9, inclusive, as shown on a plat of Camelot recorded in the RMC Office for Greenville County, South Carolina, in Plat Book WW, pages 46 and 47, have been re-cut and re-subdivided into Lots Nos. 7 through 15, inclusive, as shown on a plat of Holly Tree Plantation made by Enwright Associates, Inc., dated May 28th, 1973, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 4-X, page 35; and Lots Nos. 12 through 16, inclusive, as shown on a plat of Camelot as mentioned above, have been conveyed away in part, with the remaining portions re-cut and re-subdivided into Lots Nos. 1 through 6, inclusive, as shown on a plat of Holly Tree Plantation, made by Enwright Associates, Inc., dated May 28th, 1973 and recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 4-X, page 36.

WHEREAS, all of the undersigned are all the owners of the remaining lots shown on a plat of Camelot Subdivision made by Piedmont Engineers and Architects, dated November 5th, 1968, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book WW, pages 46 and 47, which are subject to protective covenants recorded in the RMC Office for said County and State in Deed Book 863 at page 529, and are all the owners of Lots Nos. 1 through 15, inclusive, as shown on a plat of Holly Tree Plantation, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 4-X at pages 35 and 36, which are subject to protective covenants applicable to Camelot Subdivision recorded in the RMC Office for said County and State in Deed Book 863 at page 529.

WHEREAS, Holly Tree Plantation, a subdivision adjoining and contiguous to Camelot Subdivision, is subject to certain covenants and restrictions as set forth in the Declaration of Covenants and
