INTERLOCUTORY JUDGMENT OF
DISSOLUTION OF MARRIAGE

This proceeding ~~was heard~~ ^{came on} for trial before the Honorable MARVIN H. LEWIS, Judge then presiding in Department "A" of the Oxnard Branch of the above-entitled ~~Department~~ Court on May 7, 1973, after assignment from Department "I"*

The court acquired jurisdiction of the respondent ~~on~~ ^{husband June 29, 1971} and of Respondent PLAZA MARINA COMMERCIAL CORPORATION on ~~February 26, 1973~~ ^{February 26, 1972} by:

- Service of process on that date, respondent not having appeared within the time permitted by law.
- Service of process on that date and respondent ^{Husband} having appeared.
- Respondent ^{CORPORATION} on that date having appeared.

The court orders that an interlocutory judgment be entered declaring that the parties are entitled to have their marriage dissolved. This interlocutory judgment does not constitute a final dissolution of marriage and the parties are still married and will be, and neither party may remarry, until a final judgment of dissolution is entered.

The court also orders that, unless both parties file their consent to a dismissal of this proceeding, a final judgment of dissolution be entered upon proper application of either party or on the court's own motion after the expiration of at least six months from the date the court acquired jurisdiction of the respondent. The final judgment shall include such other and further relief as may be necessary to a complete disposition of this proceeding, but entry of the final judgment shall not deprive this court of its jurisdiction over any matter expressly reserved to it in this or the final judgment until a final judgment is made of each such matter.
