the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto George O'Shields Builders, Inc., its successors and assigns forever:

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 113 of a subdivision known as Pebble Creek, Phase I as shown on plat thereof prepared by Enwright Associates, Engineers, dated October 1973, and recorded in the R. M. C. Office for Greenville County in Plat Book 5-D, pages 1-5 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Whittlin Way at the joint front corner of Lots 113 and 114 and running thence with the joint line of said lots, S. 21-41 W. 209.36 feet to an iron pin in the line of Lot 110; thence with the lines of Lots 110 and 111, N. 46-30 W. 60 feet to an iron pin and N. 47-20 W. 45 feet to an iron pin at the joint rear corner of Lots 112 and 113; thence with the joint line of said lots, N. 12-27 E. 169.49 feet to an iron pin on the southern side of Whittlin Way, joint front corner of Lots 112 and 113; running thence with the southern side of Whittlin Way, S. 70-00 E. 125.0 feet to the point of beginning;
