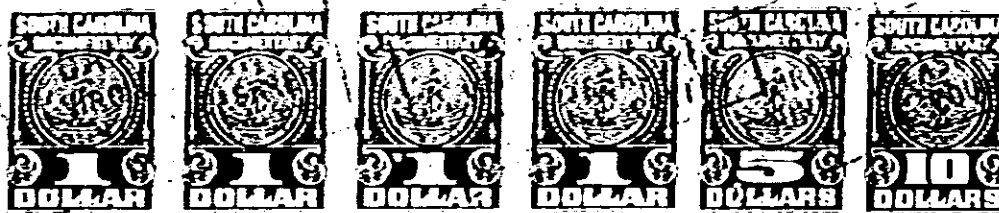

BEGINNING at an iron pin on the southerly side of Sandy Creek Court, said pin being the joint front corner of Lots 267 and 268, and running thence with the common line of said lots S 26-15-19 E 130.01 feet to an iron pin, the joint rear corner of Lots 267 and 268; thence S 66-42-32 W 194.38 feet to an iron pin, the joint rear corner of Lots 267 and 277; thence N 22-41-33 W 92 feet to an iron pin; thence N 44-09-50 E 156 feet to an iron pin on the southerly side of Sandy Creek Court; thence with the southerly side of Sandy Creek Court on a curve the chord of which is S 86-01-15 E 47.94 feet to an iron pin, the point of beginning.
