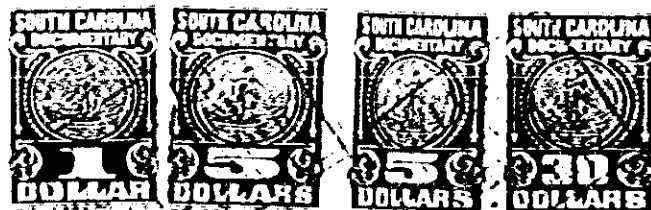
KNOW ALL MEN BY THESE PRESENTS, that James E. Wright and Rachel J. Wright
