the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto ANNIE MAE ARNOLD, her heirs and assigns forever:

ALL that certain piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, in Gantt Township, being known and designated as Lot 50 of subdivision known as Pine Hill Village as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book QQ at Pages 168 and 169 and having, according to a plat entitled "Property of Eddie Arnold" prepared by R. K. Campbell, April 15, 1965, the following metes and bounds, to wit:

BEGINNING at an iron pin on the eastern side of Cashmere Drive, joint front corner of Lots 49 and 50 and running thence along the eastern side of Cashmere Drive, following the curvature thereof, the chord being N. 26-22 W. 50 feet to an iron pin at the joint front corner of Lots 50 and 51, which pin is 401.7 feet from the intersection of Daisy Drive; thence along the joint line of Lots 50 and 51 N. 51-25 E. 145.6 feet to an iron pin at the joint rear corner of Lots 197 and 198; thence along the rear lines of Lots 198, 199 and 200, S. 15-46 E. 105.6 feet to an iron pin at the rear corner of Lot 49; thence along the joint line of Lots 49 and 50, S. 74-14 W. 125 feet to the beginning corner.

This property being the same inherited by the grantors herein from the Estate of Eddie Arnold, Deceased (See Probate File 1011, No. 21).
