All that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the westerly side of Lake Water Court, near the City of Greenville, S. C., being known and designated as Lot No. 257 on plat entitled "Map No. 1, Section One, Sugar Creek" as recorded in the RMC Office for Greenville County, S.
