ALL those pieces, parcels or lots of land, together with buildings and improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, being known and designated as Lots Nos. 26 and 27 on a Plat of the Property of Ollie B. Barrett, said Plat prepared by Terry T. Dill, dated August, 1956, and recorded in the RMC Office for Greenville County, South Carolina in Plat Book FF, Page 485, reference to which is hereby craved for the metes and bounds thereof.

The above described property is the same property conveyed to the Grantor herein by deed of Sylvia Sue Goldsmith, dated October 17, 1974, recorded in the RMC Office for Greenville County, South Carolina in Deed Book 1008, Page 813, and is hereby conveyed subject to rights of way, easements, conditions, public roads and other instruments of public record and actually existing on the ground affecting said property.

As a part of the consideration for this deed, the Grantee assumes and agrees to pay in full the indebtedness due on a Note and Mortgage given to South Carolina National Bank, dated October 18, 1974, and recorded in the RMC Office for Greenville County, South Carolina in Mortgage Book 1325, Page 377, which has a present balance due in the amount of \$8,019,50.

Grantee agrees to pay Greenville County property taxes for the tax year 1975 and subsequent tax years.
