the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Alice M. Peace and Jack B. Peace, their heirs and assigns:

ALL that certain piece, parcel or lot of land lying situate and being on the southern side of Club Circle, near Saluda Lake, being known and designated as Lot No. 3 on a Plat of property of B. T. Whitmire Estate, made by J. Mack Richardson, September, 1961, recorded in the RMC Office in Plat Book WW, at Page 202, and having, according to said plat the following metes and bounds, to wit:

BEGINNING at an Iron Pin on the southern side of Club Circle at the joint front corner of Lots Nos. 3 and 4 and running along Club Circle N. 80-02 E. for 70 feet, thence continuing along Club Circle N. 87-45 E. for 40 feet to an Iron Pin at the joint front corner of Lots Nos. 2 and 3; thence turning and running along the joint line of Lot No. 2, S. 04-11 E. for 467 feet to a point on a branch; thence turning and running along the branch for 67 feet to the joint rear corner of Lots Nos. 3 and 4; thence turning and running along the joint line of Lot No. 4, N. 12-05 W. for 447 feet to the point of beginning.
