the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

FURMAN DAVID CHANDLER AND SARA JANE WATSON LESLIE. THEIR HEIRS AND ASSIGNS FOREVER:

ALL those adjoining lots of land in the State of South Carolina, County of Greenville, containing 2.83 acres and 2.87 acres respectively, as shown on a plat of Property of Ruby Margaret Knight, prepared by C.O. Riddle, Surveyor, dated August 1975 and recorded in the RMC Office for Greenville County in Plat Book 5N at page 49 and having such metes and bounds as appear by reference to such recorded plat.

The grantees, by acceptance of this Deed, do hereby covenant and agree that such property shall not be used for commercial purposes of any kind and no mobile home shall be located on such property.

The grantor does specifically reserve unto herself, her successors and assigns, an easement for the installation of utilities and drainage of surface waters as may be needed, for the benefit of remaining property held by the grantor. Such easement shall measure five feet in width along the rear and outside lot lines on the property.

This property is conveyed subject to the aforesaid easements as well as the portion of Stenhouse Road included in such lots as shown on the recorded plat.

This is a portion of the property conveyed to the grantor as Trustee by Deed of W. A. Knight, Jr., recorded in Deed Book 1025 at page 88 in the RMC Office for Greenville County.
