KNOW ALL MEN BY THESE PRESENTS AND TO WHOM IT MAY CONCERN THAT I LOWELL JONES nee NORMAN VEAL HEREBY MAKE, CONSTITUTE AND APPOINT MRS. LOYCE DEES THESE LIMITED POWERS OF ATTORNEY FOR ME AND IN MY NAME, PLACE AND IN MY STEAD AND FOR MY USE AND BENEFIT.

(1) RECEIVE AND CASH ALL CHECKS REQUIRING MY SIGNATURE TO INCLUDE MY SOCIAL SECURITY BENEFITS

(2) DEPOSIT ALL MONIES EXCEPT THE AMOUNT I ASK FOR TO MEET MY DAILY NEEDS

(3) SIGN FOR ME ANY LEGAL DOCUMENTS THAT MAY ARISE FROM THIS DAY FORWARD

(4) PROBATE AND PAY FOR ALL NECESSARY EXPENSE OF PROBATION OF MY LAST WILL AND TESTIMONY

(5) PAY FOR THE LOCATION OF MY SON, RONALD RAY JONES, LAST KNOWN ADDRESS 1040 AINO STREET, BURLEY IDAHO. THIS EXPENSE IS TO BE TAKEN FROM HIS PART OF THE ESTATE. MY SON SHALL RECEIVE ONE HALF OF MY TOTAL ESTATE WHEN HE REACHES THE AGE OF TWENTY ONE. MY MOTHER, IONEY LITTLEJOHN WILL RECEIVE ONE FOURTH. IF SHE SHOULD PRECEDE ME IN DEATH HER SHARE SHALL GO TO MY SON, RONALD RAY JONES. ONE FOURTH SHARE SHALL GO TO MY SISTER, EXECUTRIX OF MY ESTATE.

IN CASE OF MY DEATH ONE HALF OF MY ESTATE SHALL GO INTO A SAVINGS ACCOUNT TO BE GIVEN MY SON, RONALD RAY JONES ON HIS TWENTY FIRST BIRTHDAY. IF HE IS DEAD OR CANNOT BE LOCATED BY THIS TIME AFTER DOING ALL POSSIBLE TO LOCATE HIM THEN THAT SHARE SHALL GO TO MY SISTER, LOYCE DEES THE EXECUTRIX OF MY ESTATE.

(6) SHE AND NO OTHERS EXCEPT MYSELF SHALL WITHDRAW FROM MY ACCOUNT, AND MYSELF ONLY AFTER THIRTY DAYS WRITTEN NOTICE.

(7) BE IT KNOWN THAT MY SISTER, MRS. LOYCE DEES, EXECUTRIX OF MY ESTATE IS HEREBY INSTRUCTED AND CHARGED TO DONATE MY BODY UPON MY DEATH TO THE UNIVERSITY MEDICAL SCHOOL NEAREST THE PLACE OF MY DEATH.
