REAL PROPERTY AGREEMENT

In consideration of such loans and indebtedness as shall be made by or become due to THE CHILDNA AND SOUTHERN KATIONAL BANK OF SOUTH CAROLINA (hereinafter referred to as 'fank') to or from the undersigned, jointly or severally, and until all of such loans and indebtedness have been paid in full, or until twenty-one years following the death of the last survivor of the undersigned, whichever first occurs, the undersigned, jointly and severally, promise and agree

- 1. To pay, prior to becoming delinquent, all taxes, assessments, dues and charges of every kind imposed or levied upon the real
- 2. Without the prior written consent of Esrk, to refrain from creating or permitting any lien or other encumbrance (other than those presently existing) to exist on, and from transferring, selling, assigning or in any manner disposing of, the real property describes below, or any interest therein; and
- 3. Hereby assign, transfer and set over to Bank, its successors and assigns, all montes now due and hereafter becoming due to the undersigned, as rental, or otherwise, and howscever for or on account of that certain real property situated in the County of Greenville . State of South Carolina, described as follows:

ALL that certain piece, parcel or lot of land situate, lying and being in Greenville Township, Greenville County, South Carolina, and known and designated as Lot # 3. Section "J" of Woodville Heights subdivision, plat fo which was made by W. J. Riddle, Surveyor, December 1940, recorded in plat book "K" at pages 273-275 in the RMC Office for Greenville County South Carolina, said lot having a frontage of 100 feet on the east side of Spruce Street, a depth of 155.8 feet on the south side, a depth of 154.9 feet on the north side, and a rear width of 99.7 feet.

and hereby irrevocably authorize and direct all lessees, escrow holders and others to pay to Bank, all rent and all other montes whatscever and whenseever becoming due to the undersioned, or any of them, and howscever for or on account of said real property, and hereby irrevocably appoint Bank, as attorney in fact, with fall power and authority, in the name of the undersigned, or in its own name, to endorse and negotiate checks, drafts and other instruments received in payment of, and to receive, receipt for and to enforce payment, by suit or otherwise, of all said rents and sizes, but agrees that Bank shall have no obligation so to do, or to perform or discharge any soligation, duty or liability of the indersigned in connection therewith.

- 4. That if default he made in the performance of any of the terms hereof, or if any of said rental or other sums be not paid to Bank when due, Bank, at its election, may implied the entire remaining unpaid principal and interest of any obligation or indebtedness then remaining unpaid to Bank to be due and cayable forthwith
- 5. That Bank way and is hereby authorized and permitted to cause this instrument to be recorded at such time and in such places as Bank, in its discretion, may elect.
- 6. Upon payment of all indebtedness of the undersigned to Eank this agreement shall be and become void and of no effect, and until then it shall apply to and bind the undersigned, their heirs, legatees, devisees, administrators, executors, successors and assigns, and inure to the benefit of Bank and its successors and assigns. The affidavit of any officer or department manager of Bank showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and continuing force of this agreement and any person may and is hereby authorized to rely thereon.
