the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell Douglas F. Dent, his heirs and assigns, forever:

ALL that piece, parcel or tract of land situate, lying and being in Greenville County, South Carolina, on the northwesterly side of Flicker Drive, containing 2.53 acres, and having, according to a plat of the property prepared by C.O. Riddle, dated December, 1966, and recorded in the R.M.C. Office for Greenville County in Plat Book 000 at page 81, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwesterly side of Flicker Drive at the joint front corner of the property herein conveyed and other property of Ernestine P. Smith and running thence with the common line of said property N. 46-00 W. 512.8 feet to an iron pin in the line of property now or formerly of Raford H.
