KNOW ALL MEN BY THESE PRESENTS, that Alberta Hagood and James Mackey

in consideration of One and 00/100 (\$1.00) ----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Louise Dial

All that lot of land situate on the southerly side of a 50 foot private road in the County of Greenville, State of South Carolina, being shown as Tract B on a plat of the property of a portion of the Willie Mackey Estate dated February 6, 1976, prepared by Freeland and Associates, recorded in Plat Book 5-C, at Page 77 in the RMC Office for Greenville County and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point near the center of said 50 foot private road at the corner of Tract A and running thence with Tract A S. 12-22 E. 25 feet to an iron pin; thence still with Tract A N. 76-41 E. 973.1 feet to an iron pin on the bank of Reedy River; thence S. 54-43 W. 1278 feet to an iron pin; thence N. 14-15 W. 497.6 feet to an iron pin near the center of said 50 foot private road; thence with said road N. 76-20 E. 217.4 feet to the point of beginning, and containing 6.625 acres.

This property is conveyed subject to a 50 foot private road for ingress and egress as shown on the aforementioned plat, and other plats of the Willie Mackey Estate recorded in the RMC Office for Greenville County.

Also the grantee and her heirs and assigns herein are granted the right to use a 30 foot easement which was reserved for Willie Mackey in deed recorded in Deed Book 298, at Page 395 in the RMC Office for Greenville County.

This is a portion of the property conveyed to Willie Mackey by deed recorded in Deed Book 38, at Page 234 in the RMC Office for Greenville County. The said Willie Mackey died intestate as a resident of Greenville County on May 16, 1963, leaving as his sole heirs at law his widow Bell Mackey and his children Janie Mae Mitchell, Louise Dial, Octavia Durant, Alberta Hagood, James Mackey and Broadus Mackey. The said Broadus Mackey has since died intestate as a resident of Brooklyn, New York on September 18, 1975, not having married and leaving no

And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') heirs, successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee's(s') heirs, successors and assigns against the grantor(s) and the grantor's(s') heirs, successors and assigns and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
