All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 3 of property known as Sanders Knoll, property of Ben C. Sanders, according to a plat thereof prepared by C. O. Riddle, Surveyor, dated March, 1972 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point in the center of S. C.
