in consideration of Two Thousand and No/100 ----- (\$2,000.00) ----- Dollars,

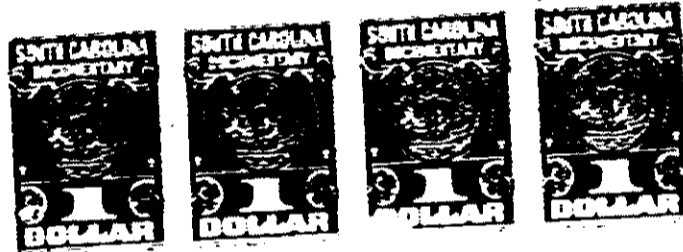
