the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto HOWARD W. COVINGTON, JR., his heirs and assigns:

All that piece, parcel or lot of land, situate, lying and being on the northern side of Henderson Road, in the city of Greenville, county of Greenville, state of South Carolina, being known and designated as Lot No. 7 as shown on "Re-Plat of Property of Joe W. Hiller, et al", said plat dated June 14, 1968 and recorded in Plat Book PPP at page 52 in the RMC Office for Greenville County, South Carolina, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Henderson Road at the joint corner of Lots No. 6 and 7 and running along Henderson Road, S. 49-57 W. 78.5 feet to an iron pin; thence running along the joint line of Lots No. 7 and 8, S. 62-59 E. 147.33 feet to an iron pin; thence continuing along the joint line of Lots No. 7 and 8, S. 34-15 E. 216.6 feet to an iron pin; thence running along the rear line of Lot No. 7, N. 55-40 E. 150 feet to an iron pin, joint rear corner of Lots No. 6 and 7; thence running along the joint line of Lots No. 6 and 7, S. 33-15 E. 337 feet to an iron pin, the point of beginning.

The grantor does hereby transfer, sign and convey to the grantee, any and all easements and/or rights of access to Lot No. 7 which he may have across Lots No. 5 and 6 as shown on the above mentioned plat.

This property is conveyed subject to all restrictions, easements, rights-of-way, and covenants which may appear of record or on the ground.

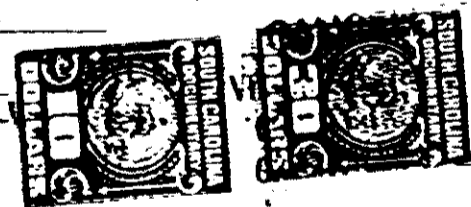
