KNOW ALL MEN BY THESE PRESENTS, that I, Lee Harold Finley,

in consideration of Thirty-one Thousand Five Hundred and no/100 (\$31,500.00)--- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Wm. Barnes O'Connor and Elizabeth M. O'Connor, their heirs and assigns:

ALL that certain, piece, parcel or lot of land, with all improvements thereon situate, lying and being in the State of South Carolina, County of Greenville, on the westerly side of Miller Road in O'Neal Township, as shown on plat of property of Don and Virginia W. Williams, prepared by John A. Simmons, R.S., dated June 16, 1969, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point in the center of bridge on Miller Road, spanning South Tyger River, and thence with the center line of the river as the line, the traverse lines of which are S. 83-31 W. 103.3 feet to a point; thence S. 85-55 W. 211.4 feet to a point; thence S. 69-03 W. 238 feet to a point; thence S. 88-31 W. 109.6 feet to a point; thence N. 7-30 E. 211 feet to an iron pin; thence still with the center line of the river, the traverse lines of which are S. 89-19 W. 385.5 feet to a point; thence N. 84-45 W. 163 feet to a point; thence N. 28-30 W. 161 feet to an old iron pin; thence along the boundary of Paul Green (or formerly) property S. 36-15 E. 507 feet to old iron pin; thence N. 89-05 E. 297 feet along southern boundary of Clara Waters (or formerly) property to new iron pin; thence S. 14-10 W. 342.5 feet to new iron pin; thence S. 83-40 E. 601 to the center of Miller Road; thence along said Miller Road on an angle, the chord of which is S. 2-45 W. 89.4 feet to a point; thence further along said road on an angle, the chord of which is S. 1-15 E. 83 feet to a point; thence along the center of said road S. 5-22 E. 137.9 feet to point in center of bridge spanning South Tyger River, the point of beginning, and containing 12.39 acres, more or less. THIS conveyance is made subject to any restrictions, easements, or rights-of-way affecting the above described property.

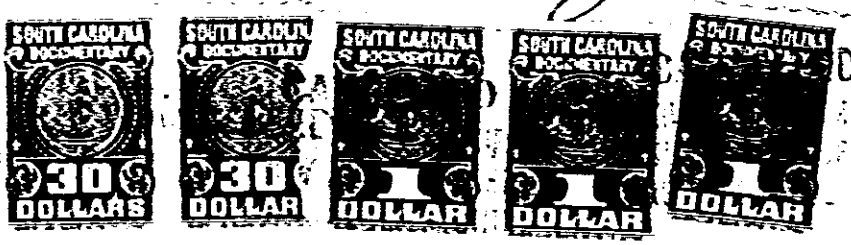
