ALL that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, being known and designated as Lot Number 16, Section 1, as shown on plat entitled Subdivision for Abney Mills, Brandon Plant, Greenville, South Carolina, made by Dalton & Neves dated February 1959, recorded in Plat Book QQ at pages 56 through 59 and having according to said plat the following metes and bounds, to-wit:

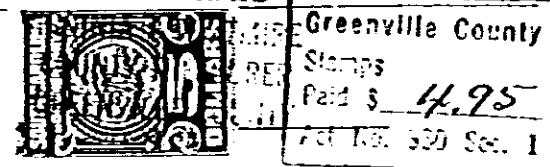
