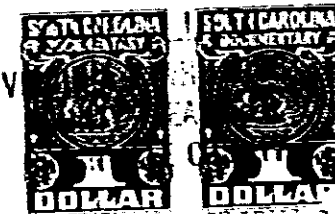
Richard E. Wood, his heirs and assigns forever.
