unto C. E. Pace and Eloise T. Pace, their heirs and assigns forever;

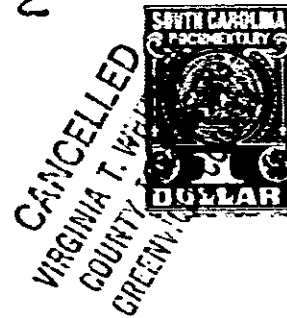
