ALL that piece, parcel or lot of land with all improvements thereon situate, lying and being on Webster Street in Ward 4 of the City of Greenville, in the County and State aforesaid and having the following metes and bounds, to wit:

BEGINNING at a stake at the corner of Lot 9 on South side of Webster Street and running S. 34-50 W. 125.65 feet to stake; thence S. 64-34 E. 65 feet to stake; thence N. 34-50 E. 126.2 feet to stake on Webster Street; thence with Webster Street N. 66-49 W. 65 feet to beginning corner and known as Lot No. 10.

ALSO: ALL that certain piece, parcel or lot of land with all improvements thereon situate, lying and being on the Southwest side of Webster Street, in the City of Greenville, County of Greenville, State of South Carolina, being shown as Lot No. 11 on plat of Oakland Heights, recorded in the RMC Office for Greenville County, S.
