

Real Property Agreement

In consideration of such loans and indebtedness as shall be made by or become due to Bankers Trust of South Carolina. N.A. (hereinafter referred to as Bank.) to or from the undersigned, jointly or severally, and until all of such loans and indebtedness have been paid in full, or until twenty one years following the death of the last survivor of the undersigned, whichever first occurs, the undersigned, jointly and severally, promise and agree.

- 1 To pay prior to becoming definiquent, all taxes assessments, dues and charges of every kind imposed or levied upon the real property described below, and
- 2 Without the prior written consent of Bank, to refrain from creating or permitting any lien or other encumbrance (other than those presently existing) to exist on, and from transferring, selling, assigning or in any manner disposing of, the real property described below, or any interest therein, or any leases, rents or funds held under escrow agreement relating to said premises; and

3 The property referred to by this agreement is described as lollows All that piece, parcel or lot of land in Chick Springs Township, Greenville County, State of S.C., lying just south from the incorporate limits of Greer & on the south side of Carey Ave., being all of lot No. 17 on a plat of the W.C. Smith property made by H.S. Brockman, Surveyor, May 25, 1936. BEGINNING at a point on southern edge of Carey Ave on corner of Lot No. 14 and runs thence S.29.54W. 160.2 ft to a point on rear line of lot No. 16; thence S. 61.02 E. 64.2 ft to a point on the rear line of lot No. 18; thence N.27.22 E.162.7 ft to a point on the southern edge of Carey Ave; thence along said Carey Ave N. 63:04 W. 57 feet to the beginning of Smithererms hereof or default be made in any payment of principal or interest on any notes hereof or the land to the land

The affidavit of any officer or department manager of Bank showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and continuing force of this agreement and any person, may and is hereby authorized to rely thereon.
