DORRAG. PROPERTY AGREEMENT Such Core in Laboral Cont.

In consideration of such loans and indebtedness as shall be made by or become due to THE SOUTH CAROLINA NATIONAL BANK OF CHARLESTON (hereinafter referred to as "Bank") to or from the undersigned, jointly or severally, and until all of such loans and indebtedness have been paid in full, or until twenty-one years following the death of the last survivor of the undersigned, whichever first occurs, the undersigned, jointly and severally, promise and agree

- 1. To pay, prior to becoming delinquent, all taxes, assessments, dues and charges of every kind imposed or levied upon the real property described below; and
- 2. Without the prior written consent of Bank, to refrain from creating or permitting any lien or other encumbrance (other than those presently existing) to exist on, and from transferring, selling, assigning or in any manner disposing of, the real property described below, or any interest therein; or any leases, rents or funds held under escrow agreement relating to said premises; and
  - 3. The property referred to by this agreement is described as follows:

All that piece, parcel, or lot of land situate, lying, and being in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as lot No. 25, Block C, Northgage Subdivision, as shown by plat recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book K, Page 113, having a frontage on the western side of North Avondale Drive of 75 feet, side lines of 148.4 feet and 145.5 feet, and a rear width of 60 fre.

Should the Veterans Administration fail or refuse to assue its guaranty of the loan secured by this instrument under the provision of the Servicemen's Readjustment Act of 1911, as amended, within sixty (60) days from the date of the lean would normally. Upon payment of all indebtedness of the undersigned to Bank this agreement shall be and become void and of no effect, and until then it shall apply to and bind the undersigned, their heirs, legatees, devisees, administrators, executors, successors and assigns, and inure to the benefit of Bank and its successors and assigns. The affidavit of any officer or department manager of a state of the benefit of Bank and its successors and assigns. Bank showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and continuing force of this agreement and any person may and is hereby authorized to rely thereon.
