for the County of Greenville aforesaid, by virtue of the aforesaid decree, & consideration of \$136.11.

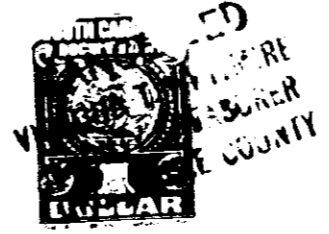
HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto
