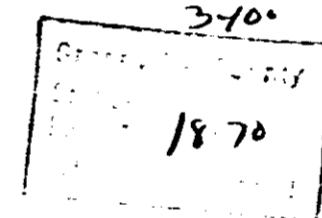
KNOW ALL MEN BY THESE PRESENTS, that William N. Miller, Jr. and Joe W. Hiller
