however to the life estate as hereinafter set forth:

AN undivided one-fourth (1/4) interest in and to the following described land:

ALL that piece, parcel or lot of land, situate, lying and being in Gantt Township, County of Greenville, State of South Carolina, being Tract No. 40, according to a plat by Dalton & Neves, recorded in the R. M. C. Office for Greenville County in Plat Book "L", page 5, containing 2.65 acres, being more fully described as follows: BEGINNING at an iron pin on Stevenson Lane, the joint corner of Tracts Nos. 17 and 40 and running thence along the line of Tracts Nos. 17 and 40, N. 31-0 W. 535 feet to an iron pin, joint corner of Tracts Nos. 16, 17 and 40; thence S. 7-42 W. 489.5 feet to an iron pin; thence S. 10-17 W. 205.4 feet to an iron pin; thence N. 60-53 E. 340 feet to an iron pin on Stevenson Lane; thence with the circle of Stevenson Lane, the chord of which is N. 9-08 E., 67.2 feet to an iron pin; thence S. 86-44 E. 68.7 feet to the point of beginning.

This conveyance is subject to a life estate in the grantor, George Chaplin, which grantor has reserved for his full use, control, income and possession of the property for and during his natural life.

This is the identical property conveyed to Mattie B. Bowman (who by marriage subsequently became Mattie B. Chaplin) by deed of J. Roy Cochran dated 6/21/46, recorded in the R.M.C. Office for Greenville County in Deed Book 294, at page 364. That by deed of the said Mattie B. Chaplin dated 12/7/55 (recorded 12/7/55) in Deed Book 540, at page 286) she conveyed a 1/2 interest to the grantor herein. Mattie B. Chaplin died testate on December 28, 1975, and the within deed is in settlement of litigation, as more fully appears in the records of the probate Court for Greenville County in File 1407, Apt. 12.
