unto John J. Brown and Helen I. Brown, their heirs and assigns forever:

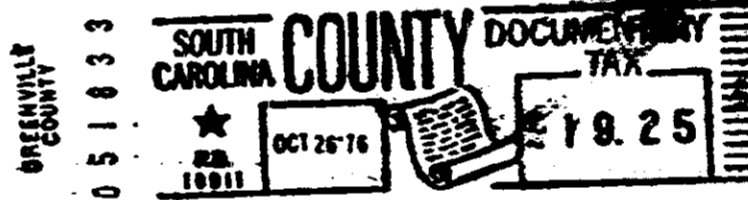
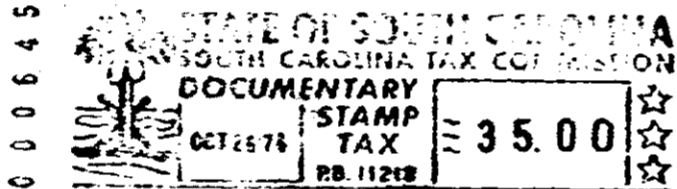
ALL that certain piece, parcel or unit, situate, lying and being in the State
