All that certain piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 25 of a subdivision entitled "A portion of Heathwilde" as shown on plat thereof prepared by Campbell & Clarkson, Surveyors, May 23, 1968 and recorded in the R.M.C. BEGINNING at an iron pin on the western edge of Surrey Lane, joint front corner of Lots Nos. 24 and 25 and running thence along the joint line of said lots, N. 84-56 W. 227.2 feet to an iron pin on the rear line of Lot No. 22; thence along the rear line of that lot, S. 18-47 W. 159.1 feet to an iron pin at the rear corner of Lot No. 21; thence along the rear line of that lot, S. 20-40 W. 90.9 feet to an iron pin at the rear corner of Lot No. 26; thence along the line of that lot, S. 83-44 E. 249.3 feet to an iron pin on a turnaround at the end of Surrey Lane; thence with the curvature of said turnaround, the chord being N. 22-39 E. 36.4 feet to an iron pin; thence continuing along the western edge of Surrey Lane, N. 12-37 E. 215 feet to the beginning corner.
