ALL that certain piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, in a subdivision known as Morgan Hill Addition, and being a portion of Lots Nos. 1, 8, 9 and 10, as shown on plat recorded in the RMC Office for Greenville County in Plat Book A, at Page 68, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwest side of Parker Road, formerly known as Monaghan Road, at the corner of lot now or formerly belonging to W. H.
