GENERAL POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS:

I hereby ratify and confirm all acts done and caused to be done by my said Attorney-in-Fact pursuant to the Power of Attorney, and I direct that it shall continue in full force and effect until terminated by operation of law. To the fullest extent permitted by law, my subsequent mental or physical incapacity shall not operate as a revocation of this Power of Attorney.

If the authority contained herein shall be revoked or terminated by operation of law without notice, I hereby agree for myself, my executor, administrators, heirs and assigns, in consideration of my attorney's willingness to act pursuant to this Power of Attorney, to save and hold my attorney harmless from any loss suffered or any liability incurred by my attorney in so acting after such revocation or termination without notice.
