bounds as shown on said plat.

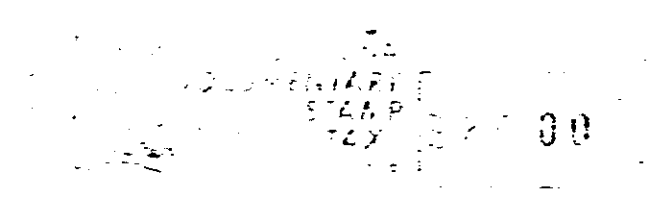
