Alex Lake and Elizabeth Lake, their heirs and assigns forever:

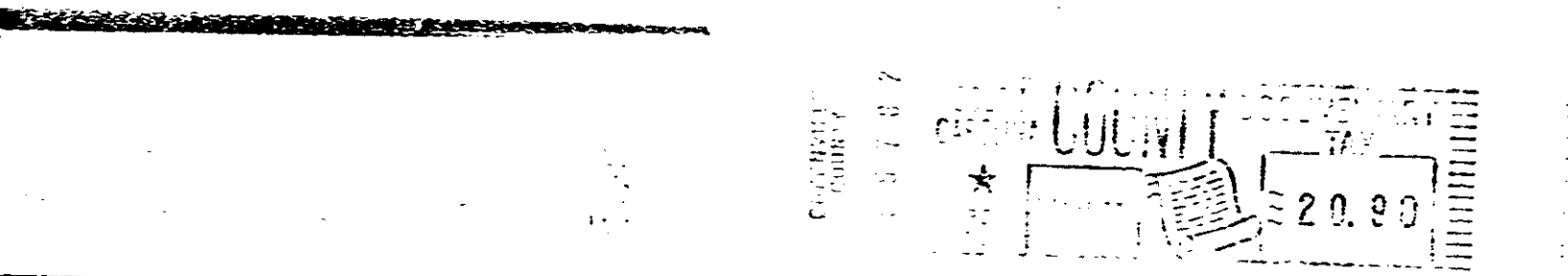
