bargain, sell and release unto Calvary Baptist Church, its successors and assigns, forever:

ALL that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina,
County of Greenville and being shown on plat of property prepared for The City of Greer, Department
of Community Development by Wolfe & Huskey, Inc., dated June 25, 1976 and having metes and
bounds, to-wit:

BEGINNING at an iron pin at the Southwesterly corner of property of Calvary Baptist Church and
running thence across Short Street in a Southerly direction S. 04-49 W. 17.34 feet to an iron pin at
the Northwestern corner of other property of Calvary Baptist Church; thence turning and running
S. 62-45 E. 114.91 feet to an iron pin at the Northeastern corner of property of Calvary Baptist
Church; thence turning and running across Short Street, N. 15-33 E. 15.30 feet to an iron pin; thence
turning and running N. 62-45 W. 118.05 feet to an iron pin, the point of beginning.

The purpose of this Deed is to convey to the Calvary Baptist Church all interest of The City of Greer
in Short Street in furtherance of action taken by the City to close said Short Street.

This conveyance is made subject to all easements, restrictions and rights of way of record and
appearing on the ground, including but not limited to a right of way to the Public Works Commission
extending through Short Street and being ten (10) feet in width.
