KNOW ALL MEN BY THESE PRESENTS, that Redmond-Huguenin Enterprises, a Limited Partnership,

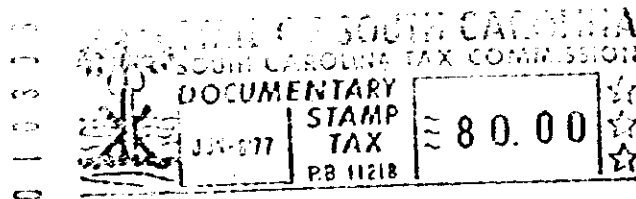
in consideration of Forty Thousand and no/100 (\$40,000.00)-----Dollars,
