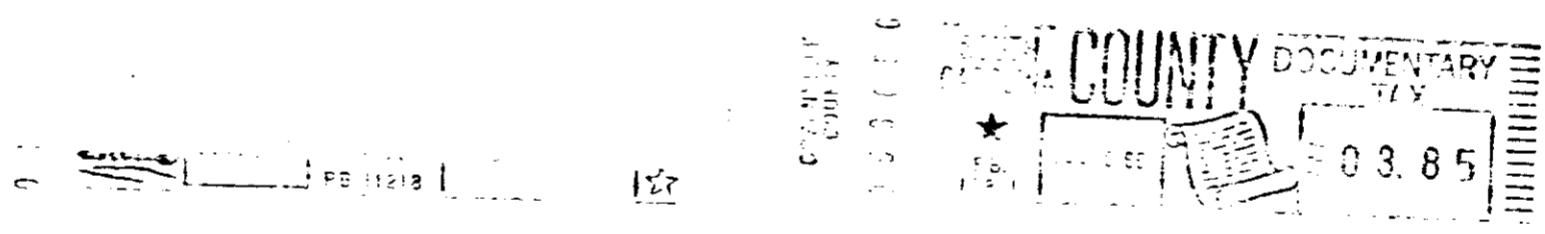
This conveyance is made subject to the restrictive covenants, building setback lines, rights of way and easements which may affect the above described property.
