in consideration of TWENTY-EIGHT THOUSAND AND NO/100 (\$28,000.00) ----- Dollars,

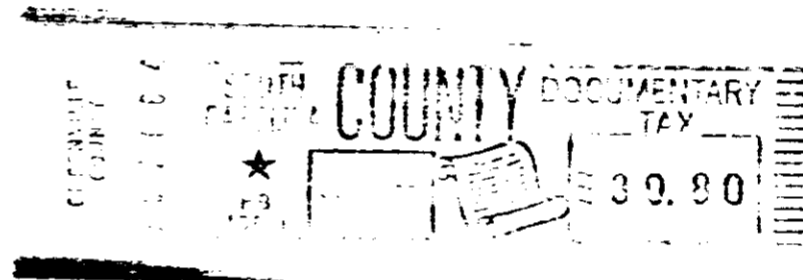
