

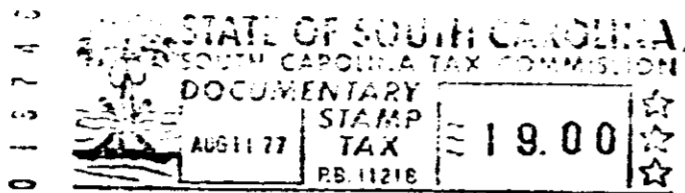

do grant, bargain, sell and release unto the said COTHRAN & DARBY BUILDERS, INC., its successors and assigns forever:

All that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the southerly side of Grey Stone Court, near the City of Greenville, S. C., being known and designated as Lot No. 217 on plat entitled " Revised Plat Lots 217 and 218, Map No. 2 Section I, Sugar Creek" as recorded in the RMC Office for Greenville County, S.
