the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto RUSSELL H. SMITH and BARBARA B. SMITH, their heirs and assigns forever:

ALL that piece, parcel or lot of land situate, lying and being on the northeastern corner of the intersection of Donnon Road and Bob White Lane, near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as the greater portion of Lot No. 15, as shown on a plat of Super Highway Homesites, prepared by Dalton & Neves, dated May, 1946, and recorded in the R.M.C. Office for Greenville County in Plat Book P at Page 53, and having according to a more recent plat prepared by Piedmont Engineering Service, dated August 28, 1961, entitled "Survey for Leslie & Shaw, Inc.", and recorded in the R.M.C. BEGINNING at an iron pin on the eastern side of Donnon Road, at the joint front corner of Lots Nos. 14 and 15, and running thence with the line of Lot No. 14, S. 88-00 E. 83 feet to an iron pin; thence a new line through Lot No. 15, S. 4-51 E. 53.1 feet to an iron pin; thence continuing a new line through Lot No. 15, S. 14-32 W. 55.9 feet to an iron pin on the northern side of Bob White Lane; thence with the northern side of Bob White Lane, S. 86-15 W. 57 feet to an iron pin; thence with the curve of the intersection of Bob White Lane and Donnon Road, the chord of which is N. 45-52 W. 33.6 feet to an iron pin on the eastern side of Donnon Road; thence with the eastern side of Donnon Road, N. 2-00 E. 90 feet to the point of beginning.
