Lessee shall pay, when due: (i) all taxes, assessments (including assessments for benefits from public works or improvements, whether or not begun or completed prior to the commencement of the term of this Lease and whether or not to be completed within said term), levies, fees, water and sewer rents and charges, and all other governmental charges, general and special, ordinary and extraordinary, and whether or not the same shall have been within the express contemplation of the parties hereto, together with any interest and penalties thereon, which are, or have been, at any time, imposed or levied upon or assessed against (A) the Leased Premises or any part thereof, (B) any Basic Rent, any Additional Rent reserved or payable hereunder or any other sums payable by Lessee hereunder and (C) this Lease or the leasehold estate hereby created or which arise in respect of the occupancy, use, operation or possession of the Leased Premises, (ii) any gross receipts or similar taxes imposed or levied upon, assessed against or measured by the Basic Rent, Additional Rent or any other sums payable by Lessee hereunder, (iii) all sales, gross receipts and use taxes which may be levied or assessed against or payable by Lessor or Lessee on account of the acquisition, leasing or use of the Leased Premises, or any part thereof, (iv) all charges for water, gas, light, heat, telephone, electricity, power and other utility and communication services rendered or used on or about the Leased Premises and (v) all other moneys not paid herein by Lessee which Lessor shall be obligated to pay pursuant to Section 4.10 of the Trust Indenture.
