Office for Greenville County, South Carolina in Deed Book 1008, Page 191, does hereby assign, transfer and set over unto Sandra Coley and Nancy A. Roper, their heirs and assigns, all of his right, title and interest in The Federal Land Bank shares purchased in connection with the above referenced loan transaction, and does hereby agree to deliver to the said Sandra Coley and Nancy A. Roper any and all evidences of ownership of the shares and to execute any and all other documents required to effect this transfer; and, by signing this Agreement, the undersigned Kenneth T. Black, individually and as Trustee, does hereby authorize The Federal Land Bank of Columbia to transfer the shares to the said Sandra Coley and Nancy A. Roper, their heirs and assigns.
