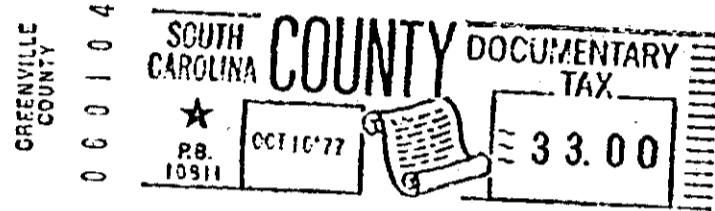
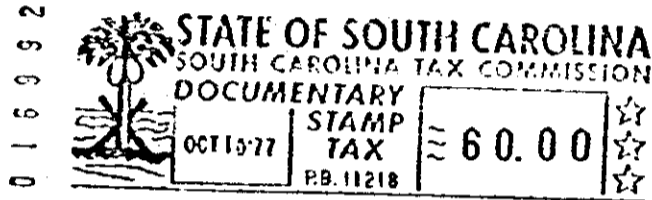
KNOW ALL MEN BY THESE PRESENTS, that WESTMINSTER COMPANY, INC, (same as Westminster Company)
