

KNOW ALL MEN BY THESE PRESENTS, that Charles Douglas Baird and Debra T. Baird,

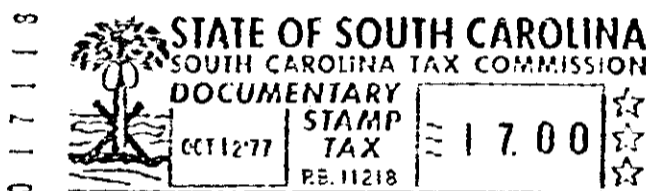
in consideration of Eight Thousand Five Hundred and 00/100 (\$8,500.00)----- Dollars,
