(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Eugene W. Brown, his heirs and assigns, forever:

A ONE-HALF UNDIVIDED INTEREST IN AND TO:

All that piece, parcel or lot of land situate, lying and being on the Northern side of Sidney Street, in the County of Greenville, State of South Carolina, being known and designated as the Western half of Lot No. 13 as shown on a plat of the Estate of J. M. Perry, prepared by R. E. Dalton, dated May, 1923, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book F at page 127, and having, according to a more recent plat, prepared by Campbell & Clarkson Surveyors, Inc., dated September 20, 1977, entitled "Property of Eugene W. Brown", and recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book 61 at page 93, the following metes and bounds:

BEGINNING at an iron pin on the Northern side of Sidney Street at the joint front corner of Lots Nos. 13 and 14 and running thence with the line of Lot No. 14 N. 31-30 W. 150 feet to an iron pin on the Southern side of Gantt Street; thence with the Southern side of Gantt Street N. 58-30 E. 25 feet to an iron pin at the rear line of Lot No. 13; thence a new line through Lot No. 13 S. 31-30 E. 150 feet to an iron pin on the Northern side of Sidney Street; thence with the Northern side of Sidney Street S. 58-30 W. 25 feet to the point of beginning.

The within conveyance is subject to such restrictions, setback lines, zoning ordinances, utility easements and rights of way, if any, as may affect the above described property.
